DR. MONICA TAYLOR (D):

TAYLOR IS A PROFESSOR AND PROGRAM DIRECTOR IN THE KINESIOLOGY DEPARTMENT AT UNIVERSITY OF THE SCIENCES IN PHILADELPHIA AND IN 2017 WAS ELECTED TO THE UPPER DARBY SCHOOL BOARD. DR. TAYLOR'S PLATFORM INCLUDES AN EMPHASIS ON ECONOMIC AND WORKFORCE DEVELOPMENT, COMMUNITY HEALTH AND PRISON REFORM. SHE SUPPORTS DEPRIVATIZING GEORGE HILL CORRECTIONAL FACILITY,

CHRISTINE REUTHER (D):

REUTHER IS CURRENTLY SERVING AS THE RUTLEDGE BOROUGH SOLICITOR. HER PLATFORM INCLUDES BRINGING GEORGE HILL UNDER PUBLIC MANAGEMENT AND IMPLEMENTING A MODERN REVIEW BOARD AT THE PRISON. SHE IS ALSO RUNNING TO PRIORITIZE ISSUES AROUND DIVERSITY AND ECONOMIC DEVELOPMENT IN DELAWARE COUNTY.



ELAINE PAUL SCHAEFER (D):

SCHAEFER IS AN ENVIRONMENTAL ACTIVIST AND FORMERLY SERVED AS THE PRESIDENT OF RADNOR TOWNSHIP'S BOARD OF COMMISSIONERS AS THE FIRST WOMAN TO DO SO. SHE IS FIGHTING FOR INCREASED LOCAL GOVERNMENT ACCOUNTABILITY AND TRANSPARENCY AND GREATER INVESTMENT IN DELCO'S NATURAL ENVIRONMENT AND RECREATIONAL FACILITIES.

JACK STOLLSTEIMER (D):

STOLLSTEIMER IS A FORMER US ATTORNEY AND ASSISTANT DISTRICT ATTORNEY IN DELCO. HE CURRENTLY SERVES ON THE DELAWARE COUNTY BAR ASSOCIATION AND IS A FOUNDING MEMBER OF DELCO COALITION FOR PRISON REFORM. STOLLSTEIMER IS RUNNING ON A 10 POINT SMART ON CRIME PLATFORM WHICH INCLUDES DEPRIVATIZING GEORGE HILL CORRECTIONAL FACILITY, REFORMING THE CASH BAIL SYSTEM, AND SUPPORTING THE ESTABLISHMENT OF A COUNTY HEALTH DEPARTMENT.

KATAYOUN COPELAND (R) (INCUMBENT):
COPELAND IS CURRENTLY DELCO'S INTERIM DA AND IS RUNNING TO SERVE A FULL TERM. SHE WAS APPOINTED TO DISTRICT ATTORNEY AFTER JACK WHELAN WAS ELECTED TO TO COURT OF COMMON PLEAS IN 2017. COPELAND WORKED IN THE COUNTY'S DISTRICT ATTORNEYS OFFICE FOR 19 YEARS, DURING WHICH SHE BECAME THE CHIEF OF DRUG ENFORCEMENT. COPELAND HAS TAUGHT MANY YEARS AT THE DELAWARE COUNTY MUNICIPAL POLICE ACADEMY AND WAS AN INSTRUCTOR FOR THE PENNSYLVANIA STATE POLICE, PENNSYLVANIA DISTRICT ATTORNEY ASSOCIATION, AND THE BUREAU OF ALCOHOL, TOBACCO, FIREARMS AND EXPLOSIVES.



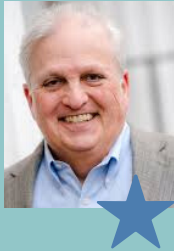
JUDGES

RICK LOWE (D):

LOWE SERVED AS THE SWARTHMORE'S FIRST DEMOCRATIC MAYOR FROM 2010-2014. OUTSIDE OF HIS PRACTICE, HE IS A VOLUNTEER AT SCI PHOENIX PRISON, WHERE HE SERVES AS AN OUTSIDE LIAISON FOR CURRENTLY INCARCERATED PEOPLE SEEKING LEGISLATION REGARDING PAROLE ELIGIBILITY FOR LIFE SENTENCES.



NUSRAT RASHID (D):

RASHID HAS HER OWN PRACTICE AND IS AN ATTORNEY SPECIALIZING IN CRIMINAL AND FAMILY LAW. RASHID HAS SERVED AS ACTING ZONING SOLICITOR FOR CHESTER TOWNSHIP.



STEPHANIE KLEIN (D):

KLEIN SERVED AS THE MAGISTERIAL JUDGE FOR MEDIA, NETHER PROVIDENCE AND SWARTHMORE FROM 1995 TO 2013 BECOMING THE FIRST WOMAN AND DEMOCRAT TO BE ELECTED TO THAT SEAT. SHE ALSO CO-CHAIRS THE WOMEN IN THE LAW COMMITTEE FOR THE DELAWARE COUNTY BAR ASSOCIATION AND SITS ON THE BOARD OF LEGAL AID OF SOUTHEAST PA.



KELLY ECKEL (D):

ECKEL IS A PARTNER AT THE DUANE MORRIS LLP LAW FIRM IN PHILADELPHIA, WHERE SHE SPECIALIZES IN CIVIL MATTERS.
